**Transportation Brokerage Agreement**

This Agreement entered into this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by and between Regatta Transportation Services LLC, Carthage, Mo. hereinafter designated as "Broker", and \_\_\_\_\_, hereinafter designated as "Carrier".

In consideration of the mutual covenants and agreements herein contained, it is hereby agreed as follows:

1. CARRIER represents that it is an Interstate Commerce Commission Authorized Contract Carrier, holding Permit No.. MC \_\_\_\_\_, and that such Permit is in full force and effect. A copy of which license is attached hereto and made apart hereof.
2. Broker is a duly licensed Motor Carrier Broker, licensed to arrange for the transportation of property by MC 548607.
3. The term of this Agreement shall be from the date first written above until the date and time of expiration or cancellation of the policy of cargo insurance of the Carrier. This agreement shall automatically renew upon the new effective date of Carrier's cargo insurance.
4. Carrier agrees to transport all shipments, within its transportation capacities, offered by Broker.
5. Carrier agrees to procure and keep in full force and effect during the term of this Agreement: Auto-Liability Insurance (\$1,000,000.00), Cargo Insurance (\$100,000.00). Broker shall be named as additional insured and Carrier shall cause its insurance agent/company to provide Broker a standard certificate of insurance evidencing such insurance. All such insurance provided by Carrier shall be deemed to be primary in the event of any loss or damage. Carrier or insurance company/agent shall notify Broker within 30 days of cancellation/non-renewal of the above insurance coverage.
6. Carrier will not solicit freight from any firm that Carrier hauled for as a result of the efforts of Broker for a period of one year after termination of the Agreement. Should Carrier breach this Agreement and obtain freight from such firm, Broker shall be entitled to a commission from Carrier of 10% of the gross revenue from such traffic for a period of 12 months after such traffic begins to move.
7. Should any portion of this Agreement be deemed unenforceable or invalid, all other provisions of this Agreement shall remain valid, binding and enforceable. This Agreement shall be governed by and construed under the laws of the State of Missouri. All disputes arising hereunder shall be heard by a court of competent jurisdiction in Jasper County, Missouri.
